Note 1:

COSMOS Forgings Ltd (Previously Global Forgings Ltd) have submitted their claim on 29-02-2020. We have intimated to them via mail dated 02-03-2020, 06-03-2020 and 10-03-2020 requesting them to send us additional documents for processing their claim.

We have later received only partial information through mail dated 11-03-2020. However, instead of continuous follow-ups via mail dated 11-03-2020, 12-03-2020, 16-03-2020 and 18-03-2020, we have till date not received complete information and supporting documents from their side.

In view of lack of information, we are unable to process their claim. Hence, their claim stands rejected.

Note 2:

Deutsche Trustee Company limited is the trustee appointed by the company for the purpose of issue of bonds worth USD 35,000,000 with an over-allotment of USD 15,000,000 in the Year 2008 per bond value being USD 100,000.

They being the trustee, have submitted Form-C to the Resolution Professional on 03-03-2020 claiming an amount of Rs 6,05,23,88,210.85 on behalf of all 500 bonds. Whereas the current status is that the Resolution Professional has already received Form-C from various bond holders, the total bonds claimed being 156 in number.

In this regard, we are unable to admit the claim of Deutsche Trustee Company limited as they cannot represent partial (remaining) Bonds and the Resolution Professional is unable to ignore Bondholders' claims already received and admitted as a part of COC.

Note 3:

The claims are rejected since they were submitted after the expiry of the last date to submit the claim i.e. 01-03-2020 (90th day from the date of CIRP)
